This National report will present activities in the field of standardization of geographical names in the Republic of Croatia in the 2021.

The Commission for the Standardization of Geographical Names adopted one technical document and worked continuously, through its working groups, on three strategic documents for the purpose of quality assurance of the Register of Geographical Names.

The improving functionality of the network application of the Register of Geographical Names and upgrading website of the Register of Geographical are in process. At the end of 2021 activities (pilot project) on the revision of the records in the database of the Register of Geographical Names began.

Activities in the field of standardization of geographical names in 2021 were presented to the public through domestic and international conferences and professional meetings.

B Member state report on the situation in their country

The progress made in the standardization of geographical names since the last UNGEGN session (news in the field of geonames in the country, progress of ongoing projects, finished projects, issues and use cases for inspiration for other countries, changes in database of geonames).

April 2021 – the Commission for the Standardization of Geographical Names adopted technical document - Methodology for revision of records in the database of the Register of Geographical Names - technical specifications. The mentioned technical specifications determine the structure of the scope of revision, preparatory activities and field research, the competence profile of the experts who conduct the revision of geographical names and the evaluation results of the revision.

October 2021 – in process - Recommendations for standardization of geographical names in the Republic of Croatia – naming of transport infrastructure.

October 2021 – in process - Guidelines for writing geographical names on maps and in other publications.

October 2021 – in process - Methodology of acting in the standardization of geographical names in the database of the Register of Geographical Names.

November 2021 – in process - activities on the revision of the records in the database of the Register of Geographical Names (pilot project).
